



EXEMPT RESOLUTION NO. 1301

Valparaiso,

WHEREAS:

The provisions of the National Customs Tariff, contained in Exempt Decree No. 473/2022, both from the Ministry of Finance, published in the Official Gazette of 10.12.2021 and 28.12.2022, respectively; in Exempt Decree No. 97/2023, of the same Ministry, published in the Official Gazette of 01. 04.2023; in the Compendium of Customs Regulations, contained in Resolution No. 1300/14.03.2006, and Exempt Resolution No. 853/08.03.2018, published in extract in the Official Gazette of 27.02.2018, both from the National Customs Directorate.

CONSIDERING:

That, in accordance with the provisions of National Legal Note No. 6 of Section 0 of the National Customs Tariff, by means of Exempt Decree No. 97, of 2023, of the Ministry of Finance, published in the Official Gazette of 01.04.2023, the amounts in dollars of the exemptions established in tariff headings 00.09, 00.23 and 00.26 of said Tariff were updated for the next 5-year period, in the following terms:

The foregoing necessitates modifying the references in the Compendium of Customs Regulations regarding the amounts of the aforementioned exemptions, as well as in other acts issued by the Service.

It has also been noted that numeral 4.1, of Annex No. 6 of Appendix XI of Chapter III of the Compendium of Customs Regulations, on "Procedure for granting the benefit contemplated in heading 00.04 of Section 0 of the National Customs Tariff", regarding "travelers' baggage", refers to Resolution No. 7264 dated 22.12.2014, of the National Director of Customs, which was left without effect, reason for which it is necessary to correct it.

CONSIDERING:

The powers granted to me by numbers 7, 8 and 29 of Article 4 of the Decree with Force of Law No. 329, of 1979, from the Ministry of Finance, Organic Law of the National Customs Service; and by Resolution No. 7/2019, of the Office of the Comptroller General of the Republic, regarding exemption from the recording process, I hereby issue the following:

RESOLUTION:

- 1. AMEND Chapter III of the Compendium of Customs Regulations as follows
 - 1.1 **REPLACE** in the first paragraph of numeral 12.4.3, the figure "US \$3,000 FOB" with "US \$4,050 FOB".
 - 1.2 **REPLACE** in numeral 13.5, the figure "US \$30.0 FOB" with "US \$41.00 FOB".
 - 1.3 **REPLACE** in Annex No. 5 of Appendix XI, numeral III with the following:

"III. EXEMPTION HEADING 0009.0200 CUSTOMS TARIFF:

Under this heading of Section 0 of the Customs Tariff, the following goods may additionally be entered:





- 1. **Travelers**: Excluding crew members, coming from Free Trade Zone or Extension Free Trade Zone, goods up to a customs value of US\$ 1,857.
- 2. **Passengers arriving from abroad:** Goods purchased in Duty-Free Shops established under Law No. 19,288, up to a customs value of US\$ 675 per trip.
- Crew members arriving from abroad: goods purchased in Duty-Free Shops established under Law No. 19,288, up to a customs value of US\$ 473 per month
- 1.4 **REPLACE** in the second paragraph of item 4.1 of Annex No. 6 of Appendix XI, the phrase 'detailed in Resolution No. 7264 dated 22.12.2014, of the National Director of Customs,' with the following: 'detailed in item I of Annex No. 5 of this Appendix.'
- 2. AMEND Chapter VII of the Compendium of Customs Regulations as follows:
 - 2.1 **REPLACE** in letter b) of numeral 1, of Title II, on the presentation of express or express delivery shipments at the customs office of entry, the figure "US \$30 FOB" with "US\$ 41 FOB".
- 3. **AMEND** Exempt Resolution No. 853/27.02.2018, of the National Director of Customs, published in excerpt in the Official Gazette on 08.03.2018, which establishes the rules to regulate the operation and administrative processes of Duty-Free Shops established under Law No. 19,288, as follows:
 - 3.1 **REPLACE** in numeral 1.3 the figures "US\$ 500.00" and "US 350.00" with "US\$ 675.00" and "US 473.00".
 - 3.2 **REPLACE** in No. 2 of numeral 9 the figures "US\$ 500.00" and "US 350.00" with "US\$ 675.00" and "US 473.00", respectively.
 - 3.3 **REPLACE** in No. 5 of numeral 9 the figures "US\$ 500.00" and "US 350.00" with "US\$ 675.00" and "US 473.00", respectively.
 - 3.4 **REPLACE** in numeral 10.3.1 the figures "US\$ 500.00" and "US 350.00" with "US\$ 675.00" and "US 473.00", respectively.
 - 3.5 **REPLACE** in numeral 10.3.2 the figures "US\$ 500.00" and "US 350.00" with "US\$ 675.00" and "US 473.00", respectively.





- 4. Without prejudice to the provisions of this resolution, the amounts of tariff headings 00.09, 00.23, and 00.26 of the National Customs Tariff referenced in resolutions or general instructions issued by the National Customs Service shall be considered updated for the next 5-year period, in accordance with the terms established by Exempt Decree No. 97/2023 of the Ministry of Finance, as detailed in the recitals of this administrative act.
- 5. **LET** the necessary maintenance be performed by the Sub-directorate of Informatics on the Customs systems, so that the transmission of declarations covering imported goods under tariff headings 00.09, 00.23, or 00.26 of the National Customs Tariff adjusts to the updated amounts established for each tariff code in Exempt Decree No. 97/2023 of the Ministry of Finance, as detailed in the recitals of this resolution.
